

Dear Holmby Westwood Community,

I am a staunch believer in community consensus and have a strong record of working with residents to collaboratively improve the quality of life in our neighborhoods based on a shared vision for our communities.

When it comes to the proposed Historic Preservation Overlay Zone (HPOZ), it is important to look at this issue with a little historic perspective. Residents began discussing this initiative around nine years ago, as a way to protect the community from mansionization, and to preserve its history. Most residents in the neighborhood seemed open to exploring an HPOZ as demonstrated by the 2011 survey conducted by the Homeowners Association.

Much has changed since that time. First, the City is close to passing an antimansionization ordinance, which will provide significant protections against wildly oversized homes. For those who supported the HPOZ just to stop mansionization, it may no longer be necessary. Second, there now is significant opposition among Holmby Westwood residents to further consideration of an HPOZ. Many area residents have expressed to me that they oppose the many restrictions found in HPOZs around the City. While these residents generally support preserving the unique character of their neighborhood, many have told me that they do not want to go to a neighborhood board to approve what color they repaint their homes, what landscaping they can put in, what stones they can use to update their walkway, or what kind of windows they can use to replace ones that break.

I have listened and met with all sides and points of view, and my office has attended numerous community meetings regarding this issue. The common theme with the Holmby Westwood Community is a strong desire to protect the neighborhood. It is also clear, however, that the proposed HPOZ is not the type of protection a majority of the community is seeking. At the end of the day, I believe that the neighborhood itself needs consensus in order to effectively implement and live within an HPOZ. That consensus simply is lacking. Therefore, I am requesting that the Planning Department terminate the proposed HPOZ for Holmby Westwood.

We will keep these conversations going.
